

OSHA does not require an employer with less than 10 employees and whose business is classified as a partially exempt industry to post Form 300A (Summary of Work-Related Injuries and Illnesses). If your company is partially exempt, but was asked in writing by OSHA or the BLS to post Form 300A, you must do so.

Please see the chart below to determine if your business is a partially exempt industry.
